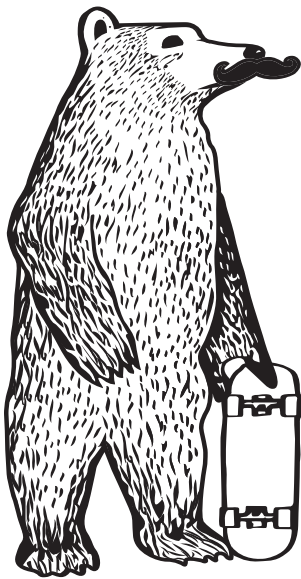

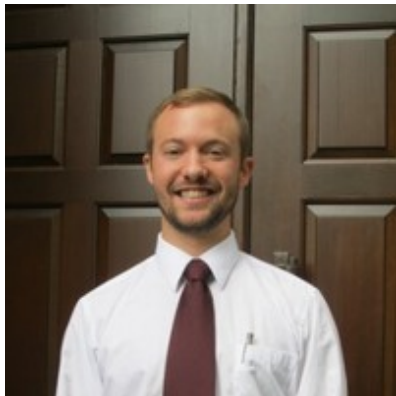
HORIZON SPEAKER: MATT CARR

Joint COVID-19 Guidelines for 2021 Summer Events at Bonclarken

The 2021 summer season of ARP events will bring unique challenges. The leadership teams of our various summer ARP events have agreed to a consistent set of general COVID-19 guidelines for conferences and camps so we can provide a quality experience for our guests while also protecting them, the Bonclarken staff, and the Bonclarken community. Much prayer and research has gone into this strategy. While these may not be the guidelines you're accustomed to following day-to-day, we ask that you agree to them in order for us to be able to gather and host these events.

We hope that these guidelines will help our guests to feel comfortable attending our 2021 summer events, but we understand that some may not. We will certainly miss you and look forward to seeing you at future ARP events at Bonclarken when these guidelines are no longer necessary.

Our strategy includes:

Contactless/limited-contact registration

We will structure Quest, Horizon, Music Conference, Music/Drama Camp, Camp Bonclarken, and Family Bible Conference registration to minimize contact and wait times.

Pre-conference screening forms and on-site checks

We will ask all guests to fill out a short questionnaire determining exposure and risk prior to attending our events. Each event will have on-site temperature and symptoms checks as well.

Adjusted refund policies

We will refund all or a portion of your deposit if you need to cancel due to COVID-19 illness or exposure. The amount for refund will be determined by each conference. This will be detailed in your registration materials. Bonclarken will refund 100% of your housing deposit or transfer your deposit to a later date at your request.

Face covering policy

In accordance with the *Guidance for Businesses* found in the *NC Requirements for the Use of Face Coverings and Masks*, businesses (including Bonclarken) are required to have patrons and employees wear face coverings whether they are inside or outside unless an exception applies. This guidance became effective February 12, 2021. We will follow this guidance at our conferences and camps unless updated guidance becomes available.

Small group-based mitigation strategies

We leaders and directors recognize that each camp/conference comes with its own unique challenges concerning human interaction. With the desire for healthy interaction in mind, we recommend for **indoor** Bonclarken activities (especially lodging, eating at the dining hall, as well as any scheduled large group worship opportunities, small group gatherings, and choirs at Music Conference) you remain with your small group of close contacts or contacts as assigned by the camp/conference, and when **outdoors** that you observe proper social distancing guidelines. Typical small groups of close contacts may be your immediate family, a group from your church, your choir group, or for campers, their cabin groups. Bonclarken will facilitate this by planning for assigned seating and spacing during worship services and at the Dining Hall.

Minimizing contacts outside of the event

We **strongly** recommend that you designate one person who will leave campus to run errands for the group as needed. We also **strongly** recommend that you consider and plan activities that will minimize or eliminate any off-campus risk of exposure during your free time. For example, while an outdoor socially distanced activity like hiking may have low risk, we do not encourage any indoor off-campus activities like eating at restaurants, visiting shops on Main Street, going to a movie, visiting potentially crowded places like Sliding Rock, etc. Please avail yourself of all that Bonclarken has to offer on campus!

Following federal, state, and local guidelines

Because Bonclarken Conference Center operates in and is governed by the state of North Carolina, we request that all attendees follow all North Carolina state COVID-19 guidelines in place at the time of your event. If you have a question or concern about a specific policy, we are happy to discuss it with you.

Registration Survey

Please answer these questions on registration day prior to your arrival at church. Anyone showing symptoms of COVID-19 or who has been in contact with someone with COVID-19 should not attend the conference.

1. Has the student had close contact (within 6 feet for at least 10 minutes) in the last 14 days with someone diagnosed with COVID-19 or has any health department been in contact with the student's family and advised them to quarantine? OR is the student awaiting results of a test for COVID-19?
 Yes. The student should not attend the conference.
 No. The student may attend if they are not experiencing symptoms (see question 2).

2. In the past 14 days, has the student had any of these symptoms? (Circle or highlight one).

If the student has any of these symptoms, they should remain at home and call their health care provider. We will refund any deposit and payments should the student be unable to attend.

Students with Prior COVID-19 Diagnosis or Symptoms

A student who has previously had COVID-19 symptoms or a positive diagnosis/COVID-19 test may attend the conference when you can answer YES to ALL six questions below:

1. Yes No Has it been at least 10 days since the student first had symptoms?
2. Yes No Has it been at least 3 days since the student has had a fever
3. Yes No Has it been at least 3 days since the student's symptoms have improved,
4. Yes No Can you affirm that the student has not had close contact
(within 6 feet for at least 10 minutes) with someone diagnosed with
COVID-19 in the past 14 days?
5. Yes No Can you affirm that your family/household is not under quarantine
orders from the health department?
6. Yes No If the student had a positive diagnosis for COVID-19, does the student
have an official document from their health care provider clearing them
to attend the retreat? You must provide an official copy at check in.

If the student has previously had COVID-19 symptoms or diagnosis, is the answer to all six questions YES?

- Yes. The student may attend the retreat.
 No. The student may not attend the retreat since they do not meet the criteria for attendance.

PACKING LIST

- Modest clothes (see Dress Code)
- Sleeping bag/sheets, pillow, towel and washcloth
- Soap, shampoo, toothpaste, etc.

GENERAL RULES

- Students are expected to attend full scheduled activities.
- No personal electronics should be used during scheduled activities.
- Students are not to leave their place of residence after "Lights Out!"
- Male and female students are not to be alone with one another (no making "purple").
- Profanity, hurtful practical jokes, and disrespect of others are prohibited.
- Personal cleanliness is encouraged.

DRESS CODE

In order to promote respect for ourselves and for the opposite sex, clear guidelines with regards to dress have been established for summer conferences. Please review these guidelines as you prepare for the conference and pack accordingly.

- Shirts should touch the waistline of shorts/pants/skirts and should cover the stomach and back. Furthermore, shorts should not be tight or low cut. There should be no exposure of cleavage or under-garments (this includes boxer shorts).
- Bathing suits must be modest.
- Shorts/skirts should be no shorter than fingertip length (When a person is standing up straight with the arms hanging straight down, their fingertips should be touching their shorts/skirts).
- Clothing should not display sexually suggestive or offensive pictures or words.
- Modesty is the key! Respect the conference staff's decisions concerning the appropriateness of your attire.

On-Site Arrangements are handled through the Bonclarken office. CEM will forward your housing preferences and information to Bonclarken and a Bonclarken representative will call you to make arrangements. 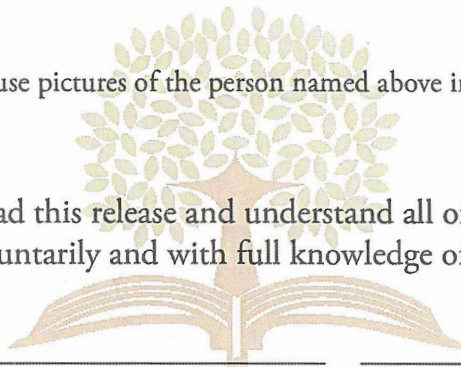

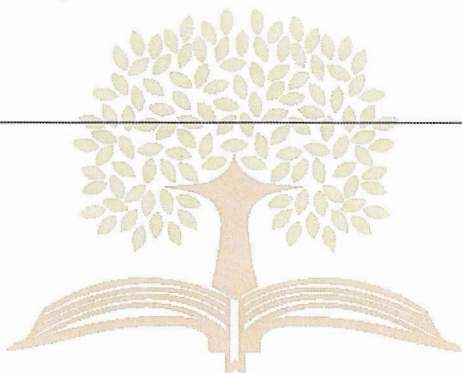
